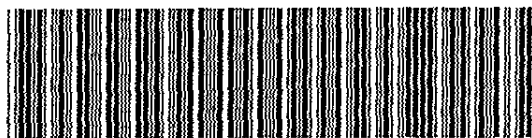

**ARTICLES OF ORGANIZATION  
OF  
STRICTLY WOOD ENTERPRISES, LLC.**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

**ARTICLE I — Name**

The name of the Limited Liability Company shall be STRICTLY WOOD ENTERPRISES, LLC. ("Company")

**ARTICLE II — Address**

The mailing address and street address of the principal office of the Company shall be 4141 N. John Young Parkway, Suite 5, Orlando, Florida 32804.

**ARTICLE III — Duration**

The Company shall commence its existence on the date these articles of organizations are filed by the Florida Department of State. The Company's existence shall be perpetual.

**ARTICLE IV — Registered Office and Agent**

**ARTICLE V — Capital Contributions**

The members of he Company shall contribute to the capital of the Company the cash, property or service as provided in the operating agreement.

**ARTICLE VI — Additional Capital Contributions**

Each member shall make additional capital contributions to the Company only on the unanimous consent of all members, or as provided in the operating agreement.

## ARTICLE VII — Admission of New Members

Except as set forth in the operating agreement, no additional members shall be admitted to the Company except with the unanimous written consent of all the members of the Company and on such terms and conditions as shall be determined by all the members. A member may transfer his or her interest in the Company as set forth in the operation agreement of the Company, but the transferee shall have no right to participate in the management of the business and affairs of the Company or become a member unless all the other members of the Company other than the member proposing to dispose of his or her interest approve of the proposed transfer by written consent.

## ARTICLE VIII — Management

The Company is to be managed by a manager or managers in accordance with operating agreement adopted by the members for the management of the business and affairs of the Company and is, therefore, a manager-managed company. The operating agreement may contain any provisions for the operating and management of the affairs of the Company not inconsistent with law or these articles of organization. 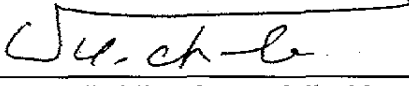
