**ARTICLES OF ORGANIZATION
OF
PAPER PLAYERS, L.L.C.**

ARTICLE I

Name

The name of the limited liability company ("Company") is PAPER PLAYERS, L.L.C.

ARTICLE II

Address

The mailing and street address of the Company's principal office is: 4758 Stoneview Circle, Oldsmar, Florida 34677.

ARTICLE III

Duration

The period of duration for the Company is perpetual, beginning on the date that these Articles of Organization are filed by the Florida Department of State.

ARTICLE IV

Registered Agent and Office

ARTICLE V

Management

ARTICLE VI

Admission of Additional or New Members

Members of the Company have the right to admit new members. Additional or new members may be admitted only on the unanimous written consent of the existing member or members, and the existing member or members shall determine the amount and nature of contributions to be made by the additional or new members at the time those new members are admitted.

ARTICLE VII

Continuance of Business

The remaining member or members of the Company have the right to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Company. The business may be continued only on the unanimous written consent of the remaining member or members. Upon the death of all members, the estate of the last member to die may operate the business until its termination.


ARTICLE VIII

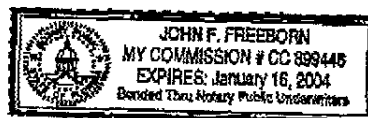
