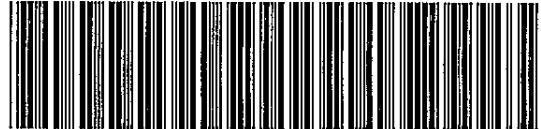

ARTICLES OF ORGANIZATION

OF

CEN FLA FIN, LLC

The undersigned, desiring to form a limited liability company pursuant to Chapter 608, Florida Statutes, the Florida Limited Liability Company Act, executes these Articles of Organization.

ARTICLE I.

EFFECTIVE DATE

5/1/03

The name of the limited liability company is CEN FLA FIN, LLC.

ARTICLE II.

The existence of the limited liability company shall commence on May 1, 2003.

ARTICLE III.

The limited liability company shall have perpetual duration.

ARTICLE IV.

The members may admit additional members only with the written consent of each member.


ARTICLE VII.
