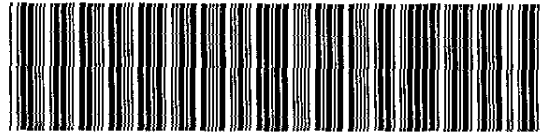

FLORIDA LIMITED LIABILITY COMPANY**

ARTICLE I -- NAME
