RECITALS

In accordance with Sections 608.407 and 608.411 of the Florida Limited Liability Company Act, Chapter 608, Florida Statutes (the "Act"), the original Articles of Organization of the Freight Rate Company, LLC (the "Company") were submitted to, and filed with, the Florida Department of State on April 29, 2003. The original Articles of Organization were amended pursuant to the Act on September 17, 2003. The articles were amended and restated in accordance with Section 605.0202(4) of the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes (the "Revised Act") on March 23, 2015, and further amended on May 5, 2015.
