#### ARTICLES OF ORGANIZATION

OF

#### NCT TECHNOLOGIES, L.L.C.

The members, for the purpose of forming a limited liability company under the Florida Limited Liability Act, F.S. Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

#### ARTICLE I - NAME

The name of the limited liability company shall be NCT Technologies, L.L.C.

#### ARTICLE II - DURATION

NCT Technologies, L.L.C. (the "Company") shall have perpetual duration.

#### ARTICLE III - PRINCIPAL PLACE OF BUSINESS AND ADDRESS
