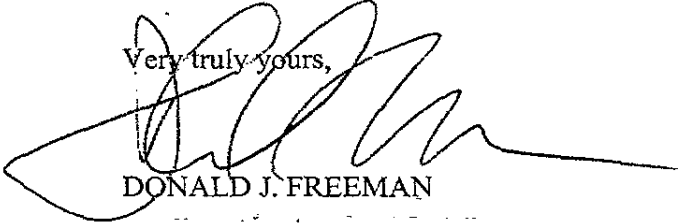

**ARTICLE I-NAME**

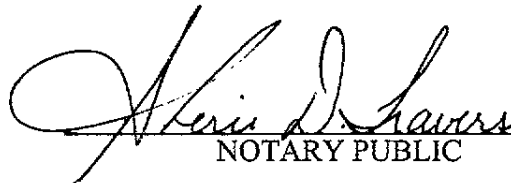

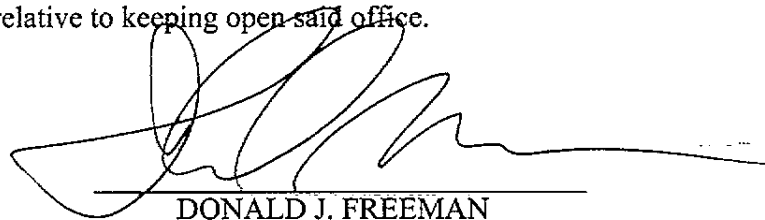
