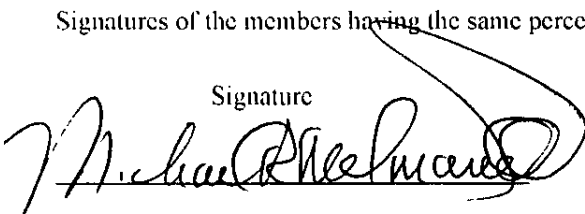

WHEREAS, the following resolution shall be presented to West Florida Medical Center Clinic, P.A., its sole Member, for approval.

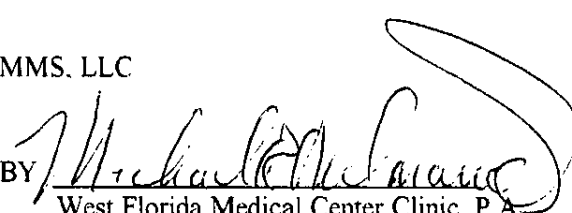
WHEREFORE, BE IT RESOLVED AS FOLLOWS:
