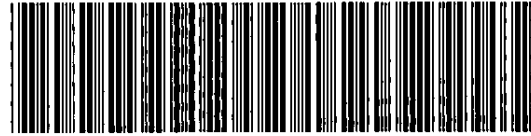


FIFTH: All remaining property and assets held by the Company have been distributed among its members in accordance with their respective rights and interests.
