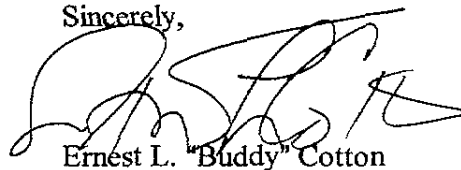

ARTICLE I - NAME

The name of this limited liability company is E.L.L. 68, L.L.C. (the "Company").

ARTICLE II - DURATION

The company shall exist from the date of filing these Articles of Organization with the Department of State, for a period of thirty (30) years or until the occurrence of any of the events specified in Florida Statutes Section 608.441, unless continued by the unanimous consent of all of the remaining members of the Company (the "Members").

VII - AMOUNT OF CASH

This Company shall begin business with ONE THOUSAND DOLLARS (\$1,000.00) cash.

ARTICLE VIII - ADDITIONAL CONTRIBUTION

The Members agree to be equally responsible for all costs and payments associated with the purchase and development of all real estate at the time and place due.

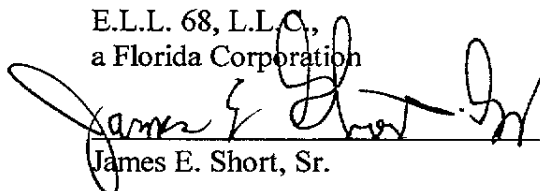
