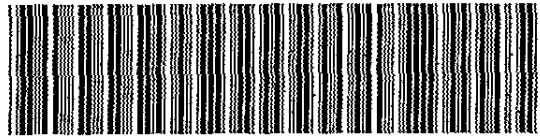

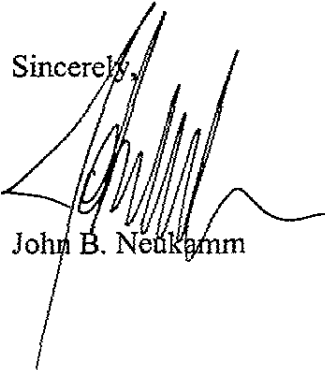

Name

The limited liability company shall have perpetual existence, commencing on April 22, 2003, when these Articles have been executed.

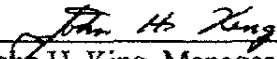
ARTICLE V
