



5. ACE RESULTS REALTY, LLC satisfies the requirements of the Florida Statutes 608.406.

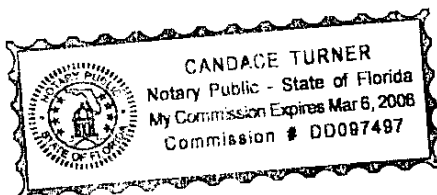
6. No further ground or grounds exist for the administrative dissolution of the Company.
