AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF HMK ENTERPRISES, LLC

Pursuant to the provisions of Chapter 608, Section 411, of the Florida Statutes, HMK ENTERPRISES, LLC, organized May 2, 2003, does hereby adopt these Amended and Restated Articles of Organization as follows:

ARTICLE I - Name

The name of the limited liability company is: HMK ENTERPRISES I, LLC

ARTICLE II - Address

The mailing address and street address of the principal office of the Limited Liability Company is: 249 8th Avenue North, St. Petersburg, Florida 33701.

ARTICLE III - Period of Duration.
