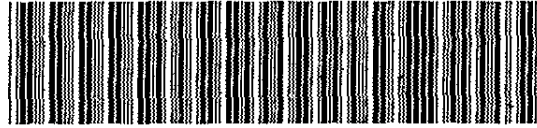

ARTICLES OF ORGANIZATION


ARTICLE 10 – MEMBERS
