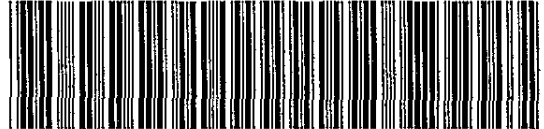

ARTICLES OF ORGANIZATION

OF

FIGORE, L.L.C.

ARTICLE I--NAME

The name of this limited liability company is FIGORE, L.L.C.

ARTICLE II--PURPOSE

The general nature of the business to be transacted by the limited liability company shall be the manufacture and sale of jewelry; and to have and exercise all of the powers now or hereafter conferred by the laws of the State of Florida upon limited liability companies organized pursuant to the laws under which this limited liability company is organized and any and all acts, amendatory thereof and supplemental thereto.

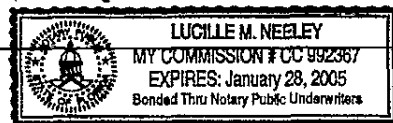
