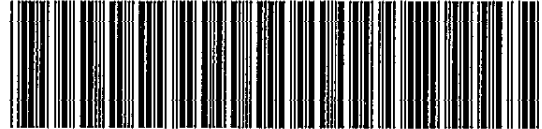


ARTICLE IV


