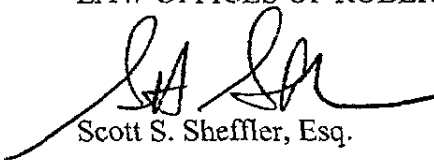

**ARTICLE IV-MANAGEMENT**

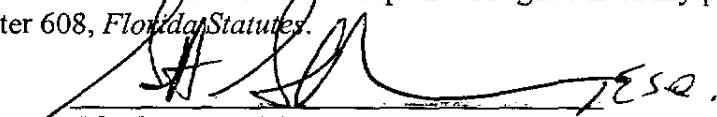
The Company shall be a manager-managed company. The initial manager shall be **WILLIAM CARPENITO**, who shall have full power and authority to bind the Company.
