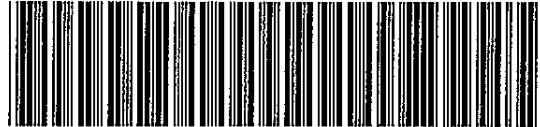

SECOND: The following amendments to the articles of organization were adopted by the limited liability company:


