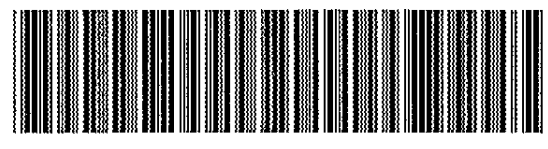



FOURTH: The date of adoption of this Amended and Restated Articles of Organization is April 9, 2004.


