ARTICLES OF ORGANIZATION

OF

ROCKY MOUNTAIN, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes, Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I

Name

The name of the limited liability company shall be Rocky Mountain, LLC (the "Company"). The mailing and street address of the principal office of the Company in Florida shall be 112 Harbourmaster Court, Ponte Vedra Beach, Florida 32082.

ARTICLE II

Duration

The Company's existence shall commence on the date these Articles of Organization are filed by the Florida Department of State and shall continue perpetually or until dissolved in accordance with these Articles of Organization adopted by the members.

Purposes and Powers

Termination of Existence



ARTICLE VIII


Manager
