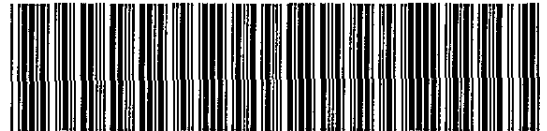

ARTICLE I - Name

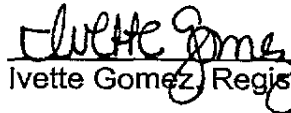
