ARTICLES OF ORGANIZATION

OF

CALOOSA INVESTMENTS, LLC

- 1. **Name**. The name of this limited liability company is CALOOSA INVESTMENTS, LLC, a Florida limited liability company (the "Company").
- 2. **Duration**. The Company shall have perpetual existence, commencing upon the date of filing of these Articles with the Florida Department of State.
