The name of the limited liability company is FALCON TRACE OF VERO BEACH, LLC.

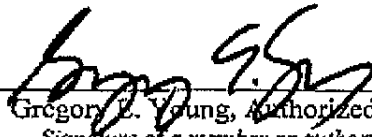
