The members reserve the right to amend, alter, change, or repeal any provision in these Articles of Organization in the manner prescribed by law.



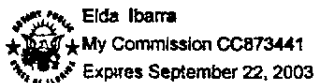
