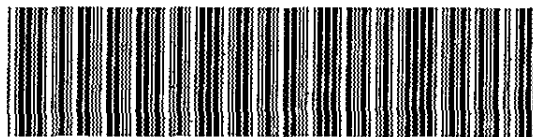

**ARTICLES OF ORGANIZATION
OF DUBOSE CHARTERS, L.L.C.
AND DESIGNATION OF REGISTERED AGENT**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be DUBOSE CHARTERS, L.L.C. ("company").

ARTICLE II -- ADDRESS

The mailing address and street address of the principal office of the company shall be 4321 Jan Cooley Drive, Panama City Beach, FL 32408.

ARTICLE III -- DURATION

The company shall commence its existence on the date these articles of organization are filed by the Florida Department of State. The company's existence shall be perpetual unless the company is earlier dissolved as provided in these articles of organization.

ARTICLE IV -- REGISTERED OFFICE AND AGENT

ARTICLE VII -- ADMISSION OF NEW MEMBERS

These regulations may contain any provisions for the regulation and management of the affairs of the company not inconsistent with law or these articles of organization.
