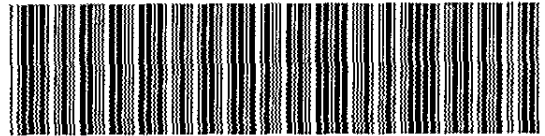

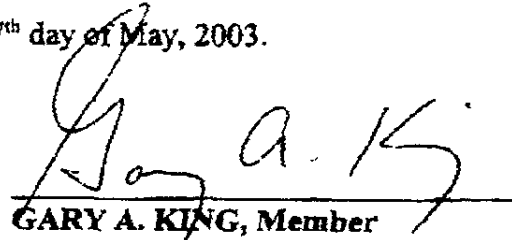
ARTICLE XI.
