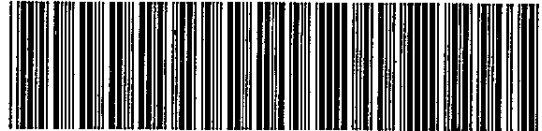

OF
ADVANCED ANESTHESIA SPECIALISTS, P.L.L.C.,

Pursuant to § 608.407 of the Florida Statutes, the undersigned does hereby submit these Articles of Organization for the purpose of forming a professional limited liability company.

ARTICLE I.

There are no other provisions which the professional limited liability company elects to include in these Articles. A separate Operating Agreement will be executed.


ARTICLE VIII.
