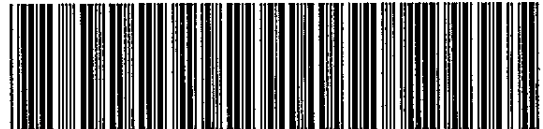

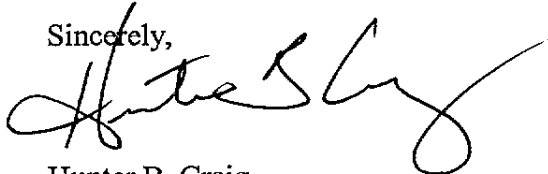

**ARTICLES OF ORGANIZATION**  
**OF**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608 Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

**ARTICLE I -- NAME**

The name of the limited liability company shall be PROJECT ONE FLORIDA, LLC ("company").

**ARTICLE II -- ADDRESS**
