**ARTICLE I
NAME**

The name of this limited liability company is Legend Realty, LLC, a Florida limited liability company (the "Company").

**ARTICLE II
DURATION**

The Company shall have perpetual existence, commencing upon the date of filing of these Articles with the Florida Department of State.


