**ARTICLES OF ORGANIZATION  
OF  
FREE BIRD LIMOUSINE, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes, Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

**ARTICLE I**

**Name**

The name of the limited liability company shall be Free Bird Limousine, LLC (the "Company"). The mailing and street address of the principal office of the Company in Florida shall be 3287 Highway 17, Orange Park, Florida 32003.

**ARTICLE II**

**Duration**

The Company's existence shall commence on the date these Articles of Organization are filed by the Florida Department of State and shall continue perpetually or until dissolved in accordance with these Articles of Organization adopted by the members.

**ARTICLE III**

**Purposes and Powers**

The general purpose for which this Company is organized is to transact any lawful business for which a limited liability company may be organized under the laws of the State of Florida. The Company shall have all the powers granted to a limited liability company under the laws of the State of Florida.

### Additional Capital Contributions

## ARTICLE VII

### Termination of Existence




