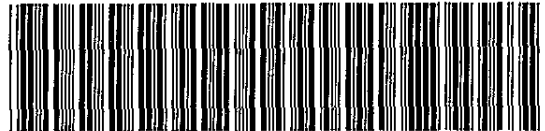

ARTICLE VIII. INITIAL REGISTERED OFFICE AND REGISTERED AGENT




