- SECOND:** The Articles of Organization were filed on May 9, 2003 and assigned document number L03000016750.
- THIRD:** The date of the adoption of these Articles of Dissolution is 29 March 2015.
- FOURTH:** The dissolution of the Limited Liability Company was a unanimous agreement of all members. It is agreed that all debts, obligations and liabilities of the limited liability company have been paid or discharged, or that adequate provision has been made, pursuant to section 605.0709.
