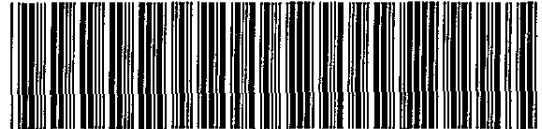

**ARTICLES OF ORGANIZATION**  
**OF**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

**ARTICLE I -- NAME**

The Member has agreed that the equity in the company shall be represented in the following manner:

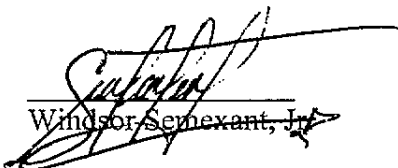

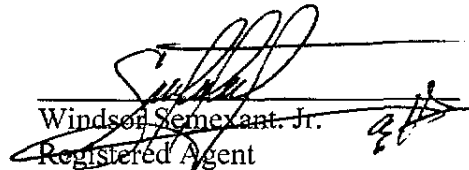
