ARTICLE VI - MANAGEMENT

The Company shall be managed by a manager or managers who shall be named at the organizational meeting of the Company.

ARTICLE VII - MEMBERS

Members shall have the right to admit new members in accordance with the terms and conditions of the regulations set forth in the Operating Agreement of the Company.
