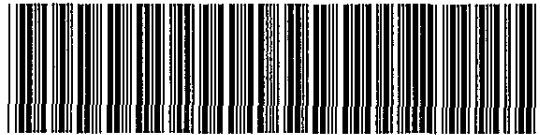

## **ARTICLES OF ORGANIZATION OF**

### **WALSTON, LLC**

The undersigned person, acting as the organizer of **WALSTON, LLC** (the "Company") under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, adopts the following Articles of Organization:

#### **ARTICLE 1. NAME AND ADDRESS**

The name, principal office, and mailing address of the Company is: Walston, LLC, 13034 Waterbourne Drive, Gibsonton, Florida 33534.

#### **ARTICLE 2. COMMENCEMENT AND DURATION OF EXISTENCE**

The existence of the Company will commence on the date that these Articles of Organization are filed with the Florida Department of State, and the existence of the Company will continue in perpetuity.

#### **ARTICLE 3. PURPOSE**

The Company may transact any or all lawful business for which a limited liability company may be organized under the Florida Limited Liability Act.

#### **ARTICLE 4. INITIAL REGISTERED AGENT AND OFFICE**

The street address of the initial registered office of the Company is 13034 Waterbourne Drive, Gibsonton, Florida 33534, and the name of the Company's initial registered agent at that address is Sherri D. Walston.

#### **ARTICLE 5. MANAGEMENT OF COMPANY**

The business of the Company shall be managed by a manager who shall be elected annually by the members of the Company in a manner set forth in the Operating Agreement. The manager shall have the power and authority to act on behalf of the Company as provided in the Florida Limited Liability Company Act, including, specifically, without limitation, Section 608.404, Section 608.424(1), and Section 608.425, and shall also hold the offices and have the responsibilities accorded by the members which are more particularly described in its Operating Agreement and any other agreement that may be entered into between the members and the manager. **ARTICLE 7. AMENDMENT OF ARTICLES OF ORGANIZATION**

Any amendment to the Articles of Organization shall be approved by a majority in interest of the members, shall be as prescribed by the Secretary of State of the State of Florida, and shall be sworn and subscribed to by a majority in interest of the members of the Company. In the event that a new member is added by such an amendment, it also shall be signed by the additional member.

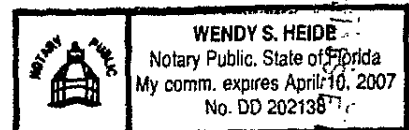
