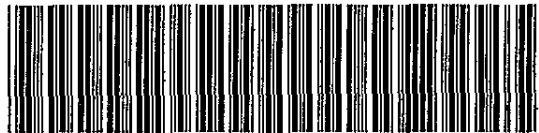



**ARTICLES OF ORGANIZATION  
OF

The undersigned, acting as organizers of ILLUCID PRODUCTIONS LLC, under the Florida Limited Liability Company Act, adopt the following Articles of Organization:

**I. NAME AND ADDRESS OF COMPANY**
