ARTICLE III - DURATION


The period of duration for Ware Family West Coast, LLC shall be perpetual commencing as of the date of filing of these Articles with the Florida Secretary of State.

Additional members may be admitted to Ware Family West Coast, LLC only upon the unanimous written consent of the existing member(s).


ARTICLE VII - MEMBERS' RIGHTS TO CONTINUE BUSINESS
