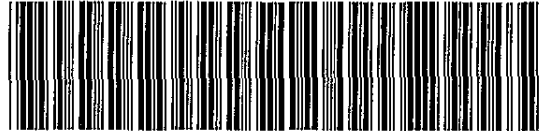

**ARTICLES OF ORGANIZATION
OF
AMERITREND COMMERCE CENTER, L.L.C.**

The undersigned, acting as Organizers of a Florida Limited Liability Company under the Florida Limited Liability Company's Act, Chapter 608 of the Florida Statutes, hereby adopts the following Articles of Organization for such Limited Liability Company.

ARTICLE I

NAME

The name of the Limited Liability Company is AMERITREND COMMERCE CENTER, L.L.C.

ARTICLE II

DURATION

The Limited Liability Company shall be perpetual from the date of filing these Articles of Organization with the Department of State.

ARTICLE III

PURPOSE

The Limited Liability Company is organized for the purpose of transacting any and all lawful business for which limited liability companies may be authorized under the laws of the State of Florida.

ARTICLE IV

ARTICLE V

DESCRIPTION OF CASH AND OTHER PROPERTY CONTRIBUTED

The members shall contribute as capital contribution to the Limited Liability Company the sum of 1,000.00. The members shall not be required to make any additional contributions to the Limited Liability Company except upon call of the company as provided for in the regulations

ARTICLE VI

ADDITIONAL MEMBERS

Additional members may be admitted to the Limited Liability Company upon unanimous vote of the members or in accordance with the regulations of the Limited Liability Company as adopted from time to time. The interest of a member of the Limited Liability Company who dies may pass to his heirs without the consent of the other members in accordance with the regulations of the Limited Liability Company as adopted from time to time.

ARTICLE VII

WITHDRAW OF A MEMBER

Upon the death, retirement, resignation, expulsion, bankruptcy, dissolution of a member, or the occurrence of any other events which terminates the continued membership of a member in the Limited Liability Company, the Company will continue to conduct its business and the membership of the withdrawing member shall be transferred in accordance with the regulations of the Limited Liability Company as adopted from time to time.

ARTICLE VIII

MANAGEMENT AND OWNERSHIP INTEREST

The Limited Liability Company is to be managed by two managers who must be members and

is, therefore, a manager-managed company. The initial Co-member-managers are P.A.D.A. PARTNERSHIP, LTD and JAMES ADAMS, as Trustee of the Mardila Trust dated June 14, 1996, 126 43rd Avenue SW, Vero Beach, FL 32968.

The names, addresses, and percentages of ownership interest of each of the members are set forth below.

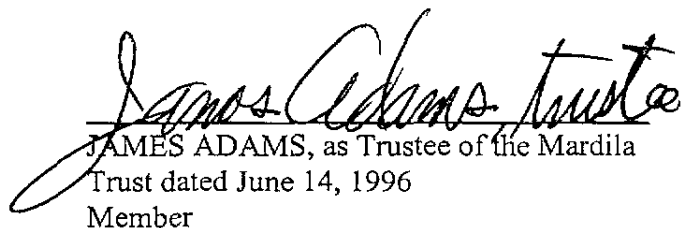
ARTICLE IX **ADOPTION OF REGULATIONS**
