**ARTICLES OF ORGANIZATION
OF
CONSORTIUM FOR MEDICAL EDUCATION, LLC**

ARTICLE I - Name

The name of the Limited Liability Company is CONSORTIUM FOR MEDICAL EDUCATION, LLC (the "Company").

ARTICLE II - Address

The mailing address and street address of the principal office of the Company is Dept. of Radiology, UCH, 3100 East Fletcher Ave., Tampa, Florida 33613.

ARTICLE III - Term

The term of the Company shall begin upon the acceptance of the Articles of Organization by the Department of State and shall be perpetual, unless its existence is sooner terminated pursuant to an agreement by the members of the Company.

ARTICLE IV - Purpose

The Company is organized for the purpose of providing medical education services and may conduct any other lawful business or activity as permitted by Florida Statutes Chapter 608.

ARTICLE V- Management

The Company is to be managed by one or more members and is therefore a member-managed company.

ARTICLE VI - Registered Agent and Office

The street address of the Company's initial registered office is 1201 Hays Street, Tallahassee, Florida 32301, and the name of its initial registered agent at such office is Corporation Service Company.

The undersigned, having been named as Registered Agent and to accept service of process for the above stated limited liability company at the place designated in these Articles of Organization, the undersigned hereby accepts the appointment as registered agent and agrees to act in this capacity. The undersigned further agrees to comply with the provisions of all statutes relating to the proper and complete performance of its duties, and is familiar with and accepts the obligations of its position as registered agent as provided for in Florida Statutes Chapter 608.

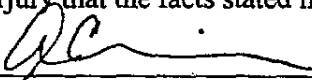
