**ARTICLES OF ORGANIZATION
FOR KENDALL COMMERCE PARK, L.L.C.**



ARTICLE VI - Members shall have the right to admit new members by unanimous consent. Contributions of the new members shall be determined at the time of admission to the Limited Liability Company.


A member's interest in the Limited Liability Company may not be sold or otherwise transferred except with unanimous written consent of all members.
