ARTICLES OF ORGANIZATION

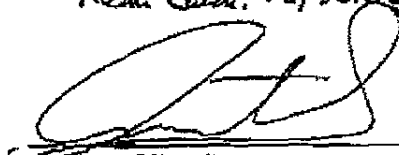
