
ARTICLE VI - MANAGEMENT

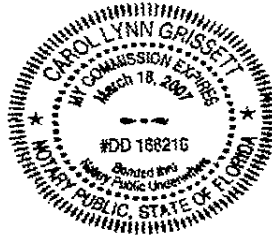
