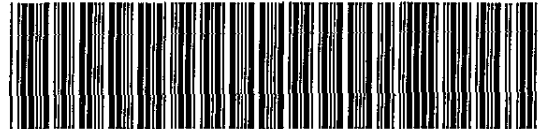

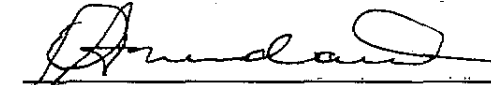

by the members.

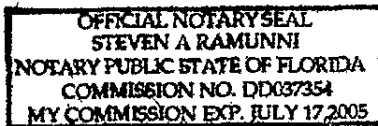

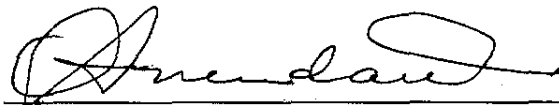
