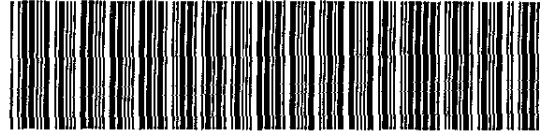

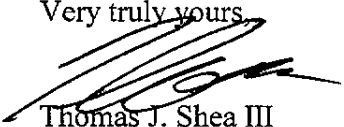

**ARTICLES OF ORGANIZATION  
OF  
CHONG O.K. L.L.C.**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, FS Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

**ARTICLE I  
NAME**

The name of the limited liability company shall be **CHONG O.K. L.L.C.** ("Company").

**ARTICLE II  
ADDRESS**

**ARTICLE III  
DURATION**

The company shall commence its existence on the date these articles of organization are filed by the Florida Department of State. The company's existence shall be perpetual unless the company is earlier dissolved as provided in these articles of organization.

ARTICLE VII  
ADMISSION OF NEW MEMBERS

No additional members shall be admitted to the company except with the unanimous written consent of all the members of the company and on such terms and conditions as shall be determined by all the members. A member may transfer his or her interest in the company as set forth in the Operating Agreement of the company, but the transferee shall have no right to participate in the management of the business and affairs of the company or become a member unless all the other members of the company other than the member proposing to dispose of his or her interest approve of the proposed transfer by unanimous written consent.

ARTICLE VIII  
TERMINATION OF EXISTENCE

The company shall not be dissolved on the death, bankruptcy, or dissolution of a member or manager, or on the occurrence of any other event that terminates the continued membership of a member in the company, as set forth in the Operating Agreement. The business of the company shall continue upon the consent of the majority of the remaining member(s), provided there is at least one remaining member acting in accordance with the Operating Agreement, as amended.

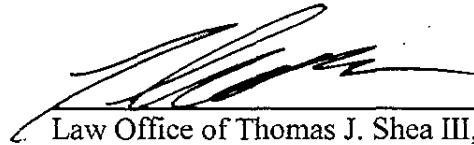

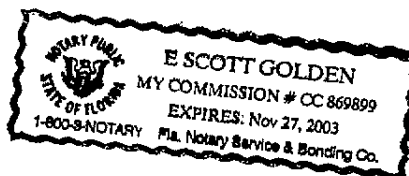
