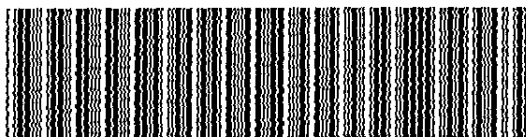


FIRST: The date of filing of the articles of organization was May 15, 2003
