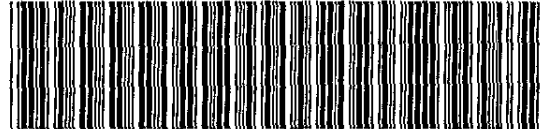

**AMENDED AND RESTATED  
ARTICLES OF ORGANIZATION FOR FLORIDA LIMITED  
LIABILITY COMPANY**

KNOW ALL MEN BY THESE PRESENTS: That Nikolay Bolotnikov, desiring to file **Amended and Restated Articles of Organization** for a previously registered limited liability company, in conformance with the Florida Limited Liability Company Act, Chapter 608, F.S., does establish and expressly state the following:

**INTRODUCTION**

The limited liability company's present registered name as originally filed is **CUSTOM HOME REPAIR AND IMPROVEMENTS, LLC**. The date of original filing with the Florida Department of State for **CUSTOM HOME REPAIR AND IMPROVEMENTS, LLC** is May 19, 2003. 

## ARTICLE VI – Assignment of Interest and Taxation

### A. - Assignment of Interest

That the Articles of Organization set forth in this document establish a member-managed limited liability company with a single member, Nikolay Bolotnikov. Nikolay Bolotnikov does hereby freely and without condition assign a fifty percent ( 50 %) interest in the limited liability company **CUSTOM HOME REPAIR AND IMPROVEMENTS, LLC**, to Larisa Bolotnikov. This assignment is intended to be permanent during the life of **CUSTOM HOME REPAIR AND IMPROVEMENTS, LLC**, and may be changed, altered or revoked only with the express, written consent and approval of Larisa Bolotnikov.


### B. – Taxation

That the limited liability company created by these Articles of Organization is disregarded as an entity separate from its owner for **federal income tax purposes** and, therefore, its activities for purposes of taxation under Chapter 220, F.S., is treated in the same manner as a sole proprietorship, branch, or division of the owner as set forth in Chapter 608.471, F.S. Such tax treatment shall remain in force and effect as long as the limited liability company created by these Articles of Organization lawfully qualifies for such tax treatment.

## ARTICLE VII – Duration

That the period of duration of this limited liability company is thirty years from the date of filing hereof with the Florida Department of State, unless sooner dissolved as provided by Florida law.
