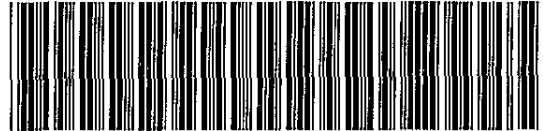

The period of duration for the Company is perpetual, beginning on the date these Articles of Organization are filed with the Florida Department of State.


**ARTICLE IV


