ARTICLES OF ORGANIZATION OF

LAWYER ASSOCIATES, LLC

THE UNDERSIGNED, for the purposes of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge and file the following Articles of Organization.

ARTICLE I - NAME OF COMPANY

The name of the limited liability company shall be Lawyer Associates, LLC (The "Company")

ARTICLE II - ADDRESS

The mailing address and street address of the principal office of the Company is 202 West Jackson Street, Pensacola, Florida 32501

ARTICLE III - DURATION

The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State. The Company's existence shall be perpetual or unless the Company is dissolved earlier as provided in these articles or in the Operating Agreement (the "Regulations").

ARTICLE IV - REGISTERED OFFICE AND AGENT
