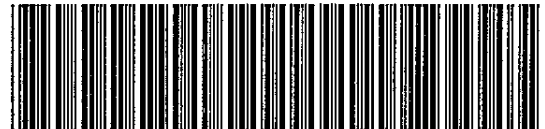

SECOND: The following amendments to the Articles of Organization were adopted by Idlewild Lodge, LLC (hereinafter referred to as the "Company")


1. Steve Martini hereby resigns as Managing Member and Member of the Company.
