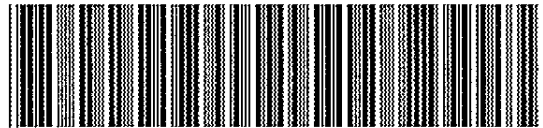

TO
ARTICLES OF ORGANIZATION

FIRST: The date of filing of the articles of organization was May 20th, 2003.

SECOND: The following amendments to the articles of organization were adopted by the limited liability company:
